

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 510 CTY HWY H, and ALLIED SUPPLY CORP and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ALLIED SUPPLY CORP include 510 CTY HWY H Elkhorn, Wisconsin USA and Allied Supply. Data collected is transmitted and stored in the US governed by US and State of Wisconsin laws.

Collection of your Personal Information
